**Number of Users:** In consideration for the license fee paid, Typodermic grants to you only, the Licensee, the non-exclusive, nontransferable right to use and display the Typodermic Product purchased through this service. Typodermic software collections consisting of one or more fonts from the Typodermic Typeface Library may be used on up to five (5) CPUs at your site connected to any number of printers or other image producing devices (regardless of resolutions) at your own site.

**Multiple Workstations:** If you have paid for a Typodermic Multi-Workstation License Agreement, then you may use the Typodermic Product on the number of CPUs stated on the receipt.

**Third Parties:** You may send a copy of any Typodermic font along with your documents to a commercial printer or other service bureau to enable the editing or printing of your document. You may also embed PC TrueType format fonts within your documents for the viewing, editing, and printing of those documents.

**Portable Documents.** You may embed Typodermic typefaces within PostScript-Language files, .PDF files, and .EVY files for distribution, viewing, and imaging to other parties.

**No Modifications.** You may not modify, adapt, translate, convert formats, reverse engineer, decompile, disassemble, or create derivative works based on the Typodermic Product without Typodermic's prior written consent.
