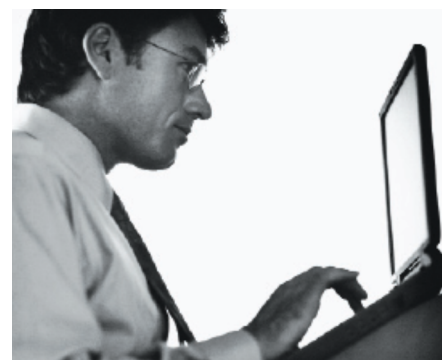

## Online Credit Account Terms & Conditions

1. fontshop.co.uk is a trading name of Creative Publishing Solutions Limited (“CPS”).
2. Upon opening an Online Credit Account with CPS you agree to be bound by these terms and any other applicable terms.
3. Online Credit Accounts are generally available to all customers based in the UK and other EEC countries, however applications from other regions will be considered (subject to status and credit check).
4. Terms of credit. A Statement/Invoice will be issued at the start of each month detailing all transactions that have taken place in the previous month. Payment will be due 30 days from the date of the Statement/Invoice. A credit ceiling will be applied to all Online Credit Accounts.
5. Purchase Order reference numbers will only be quoted on Statement/Invoices if they are entered by the customer at the point of the purchase transaction.
6. Interest charges may be levied on all overdue balances at a rate of 4% above the prevailing Bank Of England base rate. CPS reserves the right to freeze product download and to withhold credit on accounts where balances are overdue.
7. In the event of a default in payment, CPS may initiate legal proceedings and shall be entitled to recover all costs incurred by such action plus interest.
8. In all circumstances, it is the responsibility of Online Credit Account customers to safeguard access to their account. CPS will not be responsible or liable for any charges resulting from unauthorised use of the Online Account facility.
9. Some benefits made available by this facility might be subject to a charge, such charges will be payable on the same terms as those quoted in point 4. above.
10. CPS reserves the right to withdraw Online Credit Account facilities at any time and for any reason.
